The New Hampshire Bar Association's Special Committee on Rules of Criminal Procedure was asked in 1985 to draft a set of Rules of criminal procedure which would provide for greater uniformity and would enhance neither the prosecution nor defense tools in the courtroom. The Rules have been drafted to be content neutral

to the extent possible, so that changes in statutory or case law do not render the Rules irrelevant. These Rules do not use the Federal rules of criminal procedure as a template. Federal criminal procedure is quite different than traditional New Hampshire criminal practice and for that reason, the Federal rules were not thought to be a good model.
