Here the focus is on the development of measure and integration theory, differentiation and integration, Hilbert spaces, and Hausdorff measure and fractals. This book reflects the objective of the series as a whole: to make plain the organic unity that exists between the various parts of the subject, and to illustrate the wide applicability of ideas of analysis to other fields of mathematics and science. After setting forth the basic facts of measure theory, Lebesgue integration, and differentiation on Euclidian spaces, the authors move to the elements of Hilbert space, via the L^2 theory. They next present basic illustrations of these concepts from Fourier analysis, partial differential equations, and complex analysis. Each chapter has a series of exercises, from the relatively easy to the more complex, that are tied directly to the text. As with the other volumes in the series, Real Analysis is accessible to students interested in such diverse disciplines as mathematics, physics, engineering, and finance, at both the undergraduate and graduate levels. The present volume contains all the exercises and their solutions for Lang's second edition of Undergraduate Analysis. The wide variety of exercises, which range from computational to more conceptual and which are of varying difficulty, cover the following subjects and more: real numbers, limits, continuous functions, differentiation and elementary integration, normed vector spaces, compactness, series, integration in one variable, improper integrals, convolutions, Fourier series and the Fourier integral, functions in n -space, derivatives in vector spaces, the inverse and implicit mapping theorem, ordinary differential equations, multiple integrals, and differential forms. My objective is to offer those learning and teaching analysis at the undergraduate level a large number of completed exercises and I hope that this book, which contains over 600 exercises covering the topics mentioned above, will achieve my goal. The exercises are an integral part of Lang's book and I encourage the reader to work through all of them. In some cases, the problems in the beginning chapters are used in later ones, for example, in Chapter IV when one constructs-bump functions, which are used to smooth out singularities, and prove that the space of functions

This is a graduate text introducing the fundamentals of measure theory and integration theory, which is the foundation of modern real analysis. The text focuses first on the concrete setting of Lebesgue measure and the Lebesgue integral (which in turn is motivated by the more classical concepts of Jordan measure and the Riemann integral), before moving on to abstract measure and integration theory, including the standard convergence theorems, Fubini's theorem, and the Carathéodory extension theorem. Classical differentiation theorems, such as the Lebesgue and Rademacher differentiation theorems, are also covered, as are connections with probability theory. The material is intended to cover a quarter or semester's worth of material for a first graduate course in real analysis. There is an emphasis in the text on tying together the abstract and the concrete sides of the subject, using the latter to illustrate and motivate the former. The central role of key principles (such as Littlewood's three principles) as providing guiding intuition to the subject is also emphasized. There are a large number of exercises throughout that develop key aspects of the theory, and are thus an integral component of the text. As a supplementary section, a discussion of general problem-solving strategies in analysis is also given. The last three sections discuss optional topics related to the main matter of the book.

This is part one of a two-volume book on real analysis and is intended for senior undergraduate students of mathematics who have already been exposed to calculus. The emphasis is on rigour and foundations of analysis. Beginning with the construction of the number systems and set theory, the book discusses the

basics of analysis (limits, series, continuity, differentiation, Riemann integration), through to power series, several variable calculus and Fourier analysis, and then finally the Lebesgue integral. These are almost entirely set in the concrete setting of the real line and Euclidean spaces, although there is some material on abstract metric and topological spaces. The book also has appendices on mathematical logic and the decimal system. The entire text (omitting some less central topics) can be taught in two quarters of 25–30 lectures each. The course material is deeply intertwined with the exercises, as it is intended that the student actively learn the material (and practice thinking and writing rigorously) by proving several of the key results in the theory.

BartleDonald R. Sherbert The first three editions were very well received and this edition maintains the same spirit and user-friendly approach as earlier editions. Every section has been examined. Some sections have been revised, new examples and exercises have been added, and a new section on the Darboux approach to the integral has been added to Chapter 7. There is more material than can be covered in a semester and instructors will need to make selections and perhaps use certain topics as honors or extra credit projects. To provide some help for students in analyzing proofs of theorems, there is an appendix on "Logic and Proofs" that discusses topics such as implications, negations, contrapositives, and different types of proofs. However, it is a more useful experience to learn how to construct proofs by first watching and then doing than by reading about techniques of proof. Results and proofs are given at a medium level of generality. For instance, continuous functions on closed, bounded intervals are studied in detail, but the proofs can be readily adapted to a more general situation. This approach is used to advantage in Chapter 11 where topological concepts are discussed. There are a large number of examples to illustrate the concepts, and extensive lists of exercises to challenge students and to aid them in understanding the significance of the theorems. Chapter 1 has a brief summary of the notions and notations for sets and functions that will be used. A discussion of Mathematical Induction is given, since inductive proofs arise frequently. There is also a section on finite, countable and infinite sets. This chapter can be used to provide some practice in proofs, or covered quickly, or used as background material and returning later as necessary. Chapter 2 presents the properties of the real number system. The first two sections deal with Algebraic

and Order properties, and the crucial Completeness Property is given in Section 2.3 as the Supremum Property. Its ramifications are discussed throughout the remainder of the chapter. In Chapter 3, a thorough treatment of sequences is given, along with the associated limit concepts. The material is of the greatest importance. Students find it rather natural although it takes time for them to become accustomed to the use of epsilon. A brief introduction to Infinite Series is given in Section 3.7, with more advanced material presented in Chapter 9. Chapter 4 on limits of functions and Chapter 5 on continuous functions constitute the heart of the book. The discussion of limits and continuity relies heavily on the use of sequences, and the closely parallel approach of these chapters reinforces the understanding of these essential topics. The fundamental properties of continuous functions on intervals are discussed in Sections 5.3 and 5.4. The notion of a gauge is introduced in Section 5.5 and used to give alternate proofs of these theorems. Monotone functions are discussed in Section 5.6. The basic theory of the derivative is given in the first part of Chapter 6. This material is standard, except a result of Carathéodory is used to give simpler proofs of the Chain Rule and the Inversion Theorem. The remainder of the chapter consists of applications of the Mean Value Theorem and may be explored as time permits. In Chapter 7, the Riemann integral is defined in Section 7.1 as a limit of Riemann sums. This has the advantage that it is consistent with the students' first exposure to the integral in calculus, and since it is not dependent on order properties, it permits immediate generalization to complex- and vector-valued functions that students may encounter in later courses. It is also consistent with the generalized Riemann integral that is discussed in Chapter 10. Sections 7.2 and 7.3 develop properties of the integral and establish the Fundamental Theorem and many more.
