Although the GIS concepts largely remain the same in both texts, the implementation, and in some cases the terminology, has changed. with each new version but have not yet completely matched the capabilities of ArcMap. Partly for this reason, and partly to better match the rhythm of a semester, the book is now presented in 12 chapters, leaving time for instructors to better incorporate exams and projects within the semester. Some of the more advanced and less frequently used skills, such as planar topology and standards-based metadata, have been left for students to explore on their own. Second, the book includes some new topics. Raster data management has been discussed in a new chapter to acquaint students with compiling and processing raster data sets, supplementing a similar chapter on vector data management.
